RESOLUTION FOR THE APPROVAL OF THE RESUMPTION OF OPERATIONS OF AP TENDERO SPORTS ARENA DURING THE MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) PERIOD PURSUANT TO INTER-AGENCY TASK FORCE RESOLUTION NO. 79, SERIES OF 2020, AND EXECUTIVE ORDER NO. 2020-183E OF HON. ARTHUR R. DEFENSOR, JR., GOVERNOR, PROVINCE OF ILOILO.

WHEREAS, in a letter dated December 2, 2020, Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor requested for the passing of a *"Resolution For The Approval Of Operations Of The AP Tendero Sports Arena During The Modified General Community Quarantine (MGCQ) Period Pursuant To Inter-Agency Task Force Resolution No. 79, Series Of 2020, And Executive Order No. 2020-183E Of Hon. Arthur R. Defensor, Jr., Governor, Province Of Iloilo"*;

WHEREAS, the Department of Interior and Local Government (DILG) issued Memorandum Circular No. 2020-140, enjoining all concerned Local Government Units (LGUs) to undertake actions in the management of cockpits and the conduct of cockfighting activities in areas placed under Modified General Community Quarantine or lower;

WHEREAS, Inter-agency Task Force (IATF) issued Resolution No. 79, Series of 2020, allowing the operation of licensed cockpits and the conduct of cockfighting activities in areas placed under Modified General Community Quarantine or lower, subject to the strict observance of health and safety protocols and implementing guidelines;

WHEREAS, the Municipal Mayor shall be responsible in the monitoring of the re-opening of cockpits, focused mainly on no- live streaming, and public exhibition of cockfights;

WHEREAS, Inter-agency Task Force Resolution, basic protocols shall be followed; wearing of face mask, face shield, temperature check and venue disinfection, and other salient guidelines which include: no live streaming devices shall be allowed inside the arena, in-person audience, online or remote betting, live broadcasting/telecasting of cockfighting as well as shouting of bets are prohibited;

WHEREAS, to manage the impact of Covid-19, LGUs are hereby enjoined to strictly monitor the resumption of cockpit management and cockfighting activities in the Province of Iloilo;
