RESOLUTION CONFORMING AND ADOPTING MDC RESOLUTION NO. 2020-10 "RESOLUTION FOR THE FULL IMPLEMENTATION OF THE REVISED REVENUE CODE OF THE MUNICIPALITY OF TIGBAUAN EFFECTIVE JANUARY 01, 2021"

WHEREAS, the Sangguniang Bayan Tigbauan approved Municipal Ordinance No. 2019-010, the Revised Revenue Code of the Municipality of Tigbauan on December 9, 2019, indicating its date of effectivity as April 01, 2020;

WHEREAS, the Sangguniang Panlalawigan of Iloilo reviewed said ordinance declaring it to be legal and valid and returned to the Sangguniang Bayan Tigbauan on January 21, 2020;

WHEREAS, said Revised Revenue Code was only published on July 6-12, 2020;

WHEREAS, The Local Government Code of 1991 provides that this kind of ordinance shall take effect 15 calendar days after the last day of publication, which was July 27, 2020;

WHEREAS, due to the COVID-19 pandemic, most of the people's financial resources were affected, some lost their jobs while businesses are getting less customers thus affecting their income;

WHEREAS, to lessen the burden of the people in paying the fees and taxes to the Local Government Unit of Tigbauan, the effectivity of the implementation of the Revised Revenue Code was postponed;

WHEREAS, the members of the Local Finance Committee have agreed to fully implement the Revised Revenue Code of the Municipality of Tigbauan effective January 01, 2021;

WHEREAS, the members of the Municipal Development Council, through its Executive Committee passed a resolution to fully implement the Revised Revenue Code of the Municipality of Tigbauan effective January 01, 2021;
