RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO AGREEMENTS/CONTRACTS AND OTHER NECESSARY MEMORANDA FOR THE PURCHASE/ACQUISITION OF PARCELS OF LAND WITH OWNERS OF LOT NO. 928-E-2-B-2 WITH AN AREA OF 1,162 SQUARE METERS IN THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00) AND LOT NO. 928-E-2-B-1 WITH AN AREA OF 1,362 SQUARE METERS IN THE AMOUNT OF FIVE MILLION EIGHT HUNDRED SIXTY PESOS (P5,860,000.00) LOCATED AT BARANGAY NAMOCON, TIGBAUAN, ILOILO.

WHEREAS, the Local Government Unit of Tigbauan is in need of additional space/lots to accommodate the establishment of BFP Building, Peace and Order Center, Duyan ng Pag-asa, Crisis Center, Social Services Center, Liga ng mga Barangay Building and other government facilities;

WHEREAS, the Sangguniang Bayan of Tigbauan has passed a resolution approving and adopting Municipal Development Council Resolution approving Supplemental Annual Investment Program (AIP) CY 2020 and Supplemental Appropriation CY 2020 for the Purchase of Lot #928-E-2-B-1, with the land area of 1,362 square meters owned by Rodolfo L. Concepcion, in the amount of Five Million Eight Hundred Sixty Thousand Pesos (P5,860,000.00) and the Reprogramming of the Savings Surplus of CY 2020 20% Development Fund for the Purchase of Lot with the land area of 1,162 square meters owned by Clementina Zayco Mojo, Jacqueline ZaycoThoumine, Hector R. Zayco and Sandra R. Zayco in the amount of Five Million Pesos (P5,000,000.00);

WHEREAS, *Section 444(vi) of the Local Government Code provides that "the Chief Executive shall, upon authorization by the Sangguniang Bayan represent the municipality in all its business transactions and sign on its behalf all contracts and obligations, and such other documents made pursuant to law or ordinance";*
