RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO GRANT ADDITIONAL HAZARD PAY TO JOB ORDER PERSONNEL WHO RENDERED SERVICE DURING THE PERIOD OF MODIFIED ENHANCED COMMUNITY QUARANTINE AS PROVIDED FOR IN THE ADMINISTRATIVE ORDER NO. 26 DATED MARCH 23, 2020 ISSUED BY PRESIDENT RODRIGO ROA DUTERTE IN THE AMOUNT OF THREE THOUSAND PESOS (₱3,000.00) EACH CHARGEABLE AGAINST AVAILABLE BALANCE OF BUDGET FOR HAZARD PAY-EXECUTIVE SERVICES

WHEREAS, President Rodrigo Roa Duterte issued Administrative Order No. 26 authorizing the grant of hazard pay to government personnel who physically report for work during the period of implementation of an Enhanced Community Quarantine Relative To The Covid-19 Outbreak on Marche 23, 2020;

WHEREAS, Section 5, of said administrative order provides that the grant of Hazard Pay to employees in the LGU who physically report to work during the quarantine period shall be determined by their respective sanggunians depending on the LGU's financial capability subject to PS limitation in the LGU budget;

WHEREAS, job order personnel who physically report to work in the implementation of the LGU programs during the COVID-19 quarantine period are also qualified to avail of additional Hazard Pay;

WHEREAS, the Local Finance Committee of the LGU Tigbauan has certified to the availability of Funds from the balance of the budget for the payment of Hazard Pay on Executive Services;

Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie Teruñez,

RESOLVED, to authorize the Local Chief Executive to grant additional hazard pay to job order personnel who rendered service during the period of Modified Enhanced Community Quarantine as provided for in the Administrative Order No. 26 dated March 23, 2020 issued by President Rodrigo Roa Duterte in the amount of Three Thousand Pesos (₱3,000.00) each chargeable against available balance of budget for hazard pay-Executive Services”,
