RESOLUTION CONFORMING AND APPROVING THE CY 2021 BARANGAY ANNUAL BUDGET AND 20% DEVELOPMENT FUND, 10% SK FUND, 5% BDRRMF AND GAD ATTRIBUTIONS OF BARANGAY CORDOVA NORTE, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on December 14, 2020 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the 2021 Annual Budget and 20% Development Fund, 10% SK Fund, 5% BDRRMF and GAD Attributions of Barangay Cordova Norte, this municipality;

Brgy. Cordova Norte CY 2021 General Annual Budget Involving an Appropriation of P2,975,000.00 and 20% Development Fund in the amount of P573,360.20, 10% SK Fund in the amount of P297,500.00, 5% BDRRMF in the amount of P148,750.00 and GAD Attribution in the amount of P470,944.01, approved by the Sangguniang Barangay on December 6, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;

WHEREAS, the OIC-Municipal Budget Officer had reviewed in advance and endorsed to this August Body the said Barangay Annual Budget, 20% Development Plan, 10% SK Fund, 5% BDRRMF Plan and GAD Attribution which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;


