**Resolution No. 2021-004**

RESOLUTION DECLARING AS **LEGAL** AND **VALID** BARANGAY ATABAYAN ORDINANCES NOS. 2020-003, 2020-004 and 2020-005 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, on December 7, 2020, the Sangguniang Barangay of Atabayan, this municipality passed the following barangay ordinances:

- Ordinance No. 2020-003 - *"An Ordinance Declaring the 26<sup>th</sup> day of December and Every Year Thereafter as Barangay Day in Barangay Atabayan, Municipality of Tigbauan, Iloilo";*
- Ordinance No. 2020-004 - *"An Ordinance Adopting the Official Logo of Barangay Atabayan, Tigbauan, Iloilo";*
- Ordinance No. 2020-005 - *"Adopting the "Atabayan o Atabayan" as the Official Barangay Hymn of Barangay Atabayan, Tigbauan, Iloilo";*

WHEREAS, the above-mentioned Barangay Atabayan Ordinances were referred to the Committee for review and recommendation last December 9, 2020 and the committee has the following findings:

The ordinances were presented in a Barangay Assembly last November 7, 2020 and is consistent with the provisions of Section 391 of the Local Government Code, to wit:

**"SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:**

**(1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;**

**(14) Prescribe fines in amounts not exceeding One Thousand Pesos (P1,000.00) for violation of barangay ordinances;**

**(24) Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;**

WHEREAS, the same are also consistent with SECTION 16 of the LGC which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;
