RESOLUTION DECLARING VACANT THE COMPOSITION OF THE DIFFERENT STANDING COMMITTEES OF THE SANGGUNIANG BAYAN, TIGBAUAN, ILOILO.

WHEREAS, the Sangguniang Bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of Local Government Code of 1991;

WHEREAS, pursuant to Section 164(d) of the Internal Rules of Procedure of the Sangguniang Bayan, Standing Committees shall be created, in order for the members to perform the functions of their office and further exercise their mandates in serving the public;

WHEREAS, as the days pass by, there are realizations that personal experience, priorities, convictions, expertise and lot of factors affect the performance of the different members of the Sangguniang Bayan;

WHEREAS, by reorganizing the chairmanship and composition of the different standing committees, the expertise and experiences of the individual members maybe fully utilized for the betterment of service and performance;

WHEREAS, after a thorough discussion, it was agreed by the Honorable Members of the Sangguniang Bayan Tigbauan that the following committees shall be declared vacant to give way for their reorganization:

1. **COMMITTEE ON MARKET AND SLAUGHTER HOUSE**
2. **COMMITTEE ON APPROPRIATIONS, BUDGET, FINANCE AND ACCOUNTS**
3. **COMMITTEE ON ENVIRONMENTAL PROTECTION, HOUSING, LAND UTILIZATION, ZONIFICATION, ASSESSMENT AND EXPROPRIATION**
4. **COMMITTEE ON EDUCATION, TOURISM AND CIVIL SERVICE**

WHEREAS, all the other committees' chairmanship and composition shall remain the same as has been organized after the 2019 elections;
