RESOLUTION ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION & MANAGEMENT (MDRRM) PLAN OF THE MUNICIPALITY OF TIGBAUAN FOR CALENDAR YEAR 2021-2023

WHEREAS, on July 8, 2020, the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada issued Executive Order No. 42, Series of 2020, *“REORGANIZING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO”*;

WHEREAS, it is a must to reorganize the various bodies, councils and committees of the Local Government Unit (LGU) of Tigbauan, in order to update, capacitate and empower its membership under the *“New Normal”* with the end view to better serve the people of Tigbauan. The (MDRRMC)-Tigbauan strategized to strengthen its duties and functions that redound to the general welfare of the people as we face the challenges and adversities of the *“New Normal”* of today because of COVID-19 pandemic and the heightened alert for the monitoring and strict implementation of health and safety protocols of the government;

WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) shall be responsible for the adoption of disaster risk reduction and management plan that is comprehensive, integrated and promotes the involvement of all sectors and stakeholders concerned which should be derived from the local settings;

WHEREAS, the Municipal Mayor, in a letter dated January 21, 2021, forwarded to this August Body the *MUNICIPAL DISASTER RISK REDUCTION & MANAGEMENT (MDRRM) PLAN OF THE MUNICIPALITY OF TIGBAUAN FOR CALENDAR YEAR 2021-2023* and requested for the URGENT passing of a resolution adopting said MDRRM Plan;

WHEREAS, the MDRRM Plan for CY 2021-2023 represents the compositions and responsibilities of each task unit of the Municipal Disaster Risk Reduction & Management Council (MDRRMC) that will provide quality and good service in the Municipality of Tigbauan. The plan includes the use of all available resources both government and private enterprise. It is functional and designed to develop self-reliance by promoting and encouraging the spirit of self-help and mutual assistance among its constituents;

WHEREAS, the CY 2021-2023 MDRRM Plan also aims for an effective and efficient service during times of extreme emergencies giving the members of the MDRRMC the ability to function as an organized machinery despite the chaos and confusion brought by calamities and crisis;

WHEREAS, such Plan was formulated as a result of a series of consultations and meetings between the Local Government of Tigbauan, the civil society, National Government Agencies, Volunteer Groups and the Local Communities in the grassroots level in the barangays;
