RESOLUTION CONFORMING AND APPROVING THE FOLLOWING: **A.)** CY 2021 BARANGAY ANNUAL BUDGETS OF BARANGAYS: 5 (POLACION), 6 (POBLACION), 8 (POBLACION), ATABAYAN, BAGUMBAYAN, BANGKAL, BAYUCO, BINALIUAN MENOR, BUYU-AN, CANABUAN AND CORDOVA SUR **B.)** CY 2020 SUPPLEMENTAL BUDGETS OF BARANGAYS: TANPAEL AND SERMON, ALL OF THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on January 20, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the following:

- BRGY. 6 (POBLACION)** CY 2021 General Annual Budget Involving an Appropriation of **P2,041,000.00**, 20% Development Fund in the amount of **P387,370.60**, 10% SK Fund in the amount of **P204,100.00**, 5% BDRRMF in the amount of **P102,050.00** and GAD Attribution in the amount of **P176,918.53**, approved by the Sangguniang Barangay on December 27, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
- BRGY. 8 (POBLACION)** CY 2021 General Annual Budget Involving an Appropriation of **P2,649,000.00**, 20% Development Fund in the amount of **P508,661.20**, 10% SK Fund in the amount of **P264,900.00**, 5% BDRRMF in the amount of **P132,450.00** and GAD Attribution in the amount of **P261,433.06**, approved by the Sangguniang Barangay on December 6, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
- BRGY. ATABAYAN** CY 2021 General Annual Budget Involving an Appropriation of **P3,865,000.00**, 20% Development Fund in the amount of **P748,809.80**, 10% SK Fund in the amount of **P386,500.00**, 5% BDRRMF in the amount of **P193,250.00** and GAD Attribution in the amount of **P412,440.49**, approved by

the Sangguniang Barangay on December 28, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;

5. **BRGY. BAGUMBAYAN** CY 2021 General Annual Budget Involving an Appropriation of **P3,025,000.00**, 20% Development Fund in the amount of **P584,224.40**, 10% SK Fund in the amount of **P302,500.00**, 5% BDRRMF in the amount of **P151,250.00.00** and GAD Attribution in the amount of **P253,111.22**, approved by the Sangguniang Barangay on December 29, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
6. **BRGY. BANGKAL** CY 2021 General Annual Budget Involving an Appropriation of **P2,255,000.00**, 20% Development Fund in the amount of **P439,097.40**, 10% SK Fund in the amount of **P225,500.00**, 5% BDRRMF in the amount of **P112,750.00** and GAD Attribution in the amount of **P259,154.87**, approved by the Sangguniang Barangay on December 29, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
7. **BRGY. BAYUCO** CY 2021 General Annual Budget Involving an Appropriation of **P1,900,000.00**, 20% Development Fund in the amount of **P373,912.00**, 10% SK Fund in the amount of **P190,000.00**, 5% BDRRMF in the amount of **P95,000.00** and GAD Attribution in the amount of **P173,995.60**, approved by the Sangguniang Barangay on December 30, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
8. **BRGY. BINALIUAN MENOR** CY 2021 General Annual Budget Involving an Appropriation of **P2,053,000.00**, 20% Development Fund in the amount of **P406,342.60**, 10% SK Fund in the amount of **P205,300.00**, 5% BDRRMF in the amount of **P102,650.00** and GAD Attribution in the amount of **P167,117.13**, approved by the Sangguniang Barangay on December 20, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
9. **BRGY. BUYU-AN** CY 2021 General Annual Budget Involving an Appropriation of **P4,232,000.00**, 20% Development Fund in the amount of **P805,725.40**, 10% SK Fund in the amount of **P423,200.00**, 5% BDRRMF in the amount of **P211,600.00** and GAD Attribution in the amount of **P 491,086.27**, approved by the Sangguniang Barangay on December 30, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
10. **BRGY. CANABUAN** CY 2021 General Annual Budget Involving an Appropriation of **P1,944,000.00**, 20% Development Fund in the amount of **P385,262.60**, 10% SK Fund in the amount of **P194,400.00**, 5% BDRRMF in the amount of **P97,200.00** and GAD Attribution in the amount of **P242,263.13**, approved by the Sangguniang Barangay on December 29, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
11. **BRGY. CORDOVA SUR** CY 2021 General Annual Budget Involving an Appropriation of **P2,785,000.00**, 20% Development Fund in the amount of **P519,849.60**, 10% SK Fund in the amount of **P278,500.00**, 5% BDRRMF in the amount of **P139,250.00** and GAD Attribution in the amount of **P299,292.48**, approved by the Sangguniang Barangay on December 29, 2020 and was enacted thru Appropriation Ordinance No. 2020-02.

**b.) CY 2020 Supplemental Budgets of Brgys.: Tan Pael and Sermon to wit:**

1. The appropriation of **Brgy. Tan Pael** for the Supplemental Budget No. 2020-01 embodying Appropriation Ordinance No. 2020-01 in the amount of **P40,000.00** is for the One-Time Service Recognition Incentives CY 2020 chargeable against the MOOE-Training Expenses- 40,000.00 of the aforementioned barangay.
2. The appropriation of **Brgy. Sermon** for the Supplemental Budget No. 2020-01 embodying Appropriation Ordinance No. 2020-01 in the amount of **P14,175.00** is for the One-Time Service Recognition Incentives CY 2020 chargeable against the PS Savings/Surplus CY 2020-2,625.00 and MOOE-Training Expenses- 11,550.00 of the aforementioned barangay.

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the said CY 2021 Barangay Annual Budgets and CY 2020 Barangay Supplemental Budgets, show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the Review of the foregoing Annual Budgets CY 2021, and CY 2020 Barangay Supplemental Budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;
