RESOLUTION TO WITHDRAW RESOLUTION NO. 2021-009, ENTITLED: *“RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION (DOD) WITH THE PHILIPPINE RICE RESEARCH INSTITUTE (PHILRICE-NEGROS) FOR THE DONATION OF 240 BAGS OF SEEDS TO THE MUNICIPALITY OF TIGBAUAN.”*

WHEREAS, in a Letter dated January 19, 2021, the Municipal Mayor, Atty. Suzette T. Alquisada, originally requested this August Body, thru Vice Mayor Virgilio T. Teruel, for the URGENT passing of a *“Resolution Authorizing the Municipal Mayor, Atty. Suzette T. Alquisada, For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Deed Of Donation (DOD) With The Philippine Rice Research Institute (PHILRICE-NEGROS) For The Donation Of 28 Bags Of Seeds To The Municipality Of Tigbauan”*;

WHEREAS, pursuant to the said letter request of the good Mayor, Mrs. Eugenia Sayson, *Municipal Agriculturist* was invited to attend the pre-session conference to further shed light on the needed resolution and to answer queries and clarifications thereto, in aid of legislation;

WHEREAS, as a result of an exhaustive discussion during the pre-session conference among others, was the need to correct the number of sacks donated from 28 bags to 240 bags as manifested and suggested by Mrs. Sayson;

WHEREAS, in view of the said suggestion/correction of Mrs. Sayson, the aforementioned letter request of the good Mayor was corrected (*with the initial of Mr. Jay Tilos, Sr. Adm. Asst. III & Executive Secretary*) by reflecting 240 bags of seeds (*instead of 28 bags*) and the S.B. passed the needed **Resolution No. 2021-009**, entitled: *“RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION (DOD) WITH THE PHILIPPINE RICE RESEARCH INSTITUTE (PHILRICE-NEGROS) FOR THE DONATION OF 240 BAGS OF SEEDS TO THE MUNICIPALITY OF TIGBAUAN”*;

WHEREAS, on January 25, 2021, Mayor Alquisada, again forwarded another letter to this August Body (*which is included in today's Calendar of Business, under item IX. C.3.5*), informing that upon checking and confirmation with PHILRICE- Negros, the total number of bags of seeds is only twenty eight (28) (*and not 240 bags as stated under approved Resolution No. 2021-009*), hence the need to effect again such change/correction in the requested resolution;

NOW, THEREFORE, on motion of HON. NORBERTO T. TURALBA, *Chairman, Committee on Agriculture and Aquatic Resources* and duly seconded by Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to withdraw RESOLUTION NO. 2021-009, ENTITLED: *"RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION (DOD) WITH THE PHILIPPINE RICE RESEARCH INSTITUTE (PHILRICE-NEGROS) FOR THE DONATION OF 240 BAGS OF SEEDS TO THE MUNICIPALITY OF TIGBAUAN."*
