**Resolution No. 2021 – 016** 

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION (DOD) WITH THE PHILIPPINE RICE RESEARCH INSTITUTE (PHILRICENEGROS) FOR THE DONATION OF TWENTY EIGHT (28) BAGS OF SEEDS TO THE MUNICIPALITY OF TIGBAUAN

**WHEREAS**, the DONOR is mandated to implement the development, propagation, and promotion of inbred rice quality seeds (seeds) under the Rice Competitiveness Enhancement Fund (RCEF), in particular, provide certified inbred seeds to help improve the competitiveness of the Filipino rice farmers, increase their income, and sustain the resilience and responsiveness of the rice industry;

**WHEREAS**, the DONEE thru its Municipal Social Welfare Development Office (MSWDO) is mandated to address poverty-related concerns, and implement different social welfare and development programs such as relief operations and feeding programs; and is committed to the care, protection, and rehabilitation of individuals, families, groups, and communities;

**WHEREAS**, the DONOR has undistributed seeds after farmers in certain municipalities opted to plant early or were catered to by the National Rice Program of the DA, and these seeds are no longer suitable as planting materials as shown by appropriate testing procedures;

**WHEREAS**, the DONEE thru its MSWDO is very much willing to receive said undistributed rice seeds and mill the same in support of their program;

**WHEREAS**, in consideration of the aforementioned premises and their mutual covenants hereinafter set forth, the parties have agreed as follows:

- 1. That, for and in consideration of the aforesaid programs of the DONEE, the DONOR, by these presents, transfers, conveys, by way of donation, unto said DONEE, 28 bags of seeds that are no longer suitable for planting, free from all liens and encumbrances.
- 2. That the DONEE does hereby accepts this donation of 28 bags of seeds for the official use of MSWDO and hereby expresses gratitude for the kindness and generosity of the DONOR.
- 3. That the DONEE will arrange and shoulder the hauling from Municipal Agriculture Office, Tigbauan, Iloilo and milling costs of the donated seeds.
