RESOLUTION CONFORMING AND APPROVING THE CY 2021 BARANGAY ANNUAL BUDGETS OF BARANGAYS: 7 (POLACION), 9 (POBLACION), LANAG, LINOBAYAN, LUBOG, NAPNAPAN SUR, PARARA SUR, SERMON AND TARO, ALL OF THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on January 26, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2021 Brgy. Annual Budgets, 20% Development Funds, 10% SK Funds, 5% BDRRMF and GAD Attributions of Brgys: 7(Polacion), 9(Poblacion), Lanag, Linobayan, Lubog, Napnapan Sur, Parara Sur, Sermon and Taro wit:

LINOBAYAN** CY 2021 General Annual Budget Involving an Appropriation of **P1,836,000.00**, 20% Development Fund in the amount of **P362,237.00**, 10% SK Fund in the amount of **P183,600.00**, 5% BDRRMF in the amount of **P91,800.00** and GAD Attribution in the amount of **P143,861.85**, approved by the Sangguniang Barangay on December 30, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
5. **BRGY. LUBOG** CY 2021 General Annual Budget Involving an Appropriation of **P1,865,000.00**, 20% Development Fund in the amount of **P635,155.60**, 10% SK Fund in the amount of **P186,500.00**, 5% BDRRMF in the amount of **P93,250.00** and GAD Attribution in the amount of **P122,157.78**, approved by the Sangguniang Barangay on December 30, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
6. **BRGY. NAPNAPAN SUR** CY 2021 General Annual Budget Involving an Appropriation of **P2,792,000.00**, 20% Development Fund in the amount of **P539,794.40**, 10% SK Fund in the amount of **P279,200.00**, 5% BDRRMF in the amount of **P139,600.00** and GAD Attribution in the amount of **P406,189.72**, approved by the Sangguniang Barangay on December 30, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;

7. **BRGY. PARARA SUR** CY 2021 General Annual Budget Involving an Appropriation of **P3,687,000.00**, 20% Development Fund in the amount of **P712,649.60**, 10% SK Fund in the amount of **P368,700.00**, 5% BDRRMF in the amount of **P184,350.00** and GAD Attribution in the amount of **P433,232.48**, approved by the Sangguniang Barangay on December 30, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
8. **BRGY. SERMON** CY 2021 General Annual Budget Involving an Appropriation of **P1,745,000.00**, 20% Development Fund in the amount of **P343,265.00**, 10% SK Fund in the amount of **P174,500.00**, 5% BDRRMF in the amount of **P87,250.00** and GAD Attribution in the amount of **P116,763.25**, approved by the Sangguniang Barangay on December 29, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;
9. **BRGY. TARO** CY 2021 General Annual Budget Involving an Appropriation of **P1,775,000.00**, 20% Development Fund in the amount of **P349,589.00**, 10% SK Fund in the amount of **P177,500.00**, 5% BDRRMF in the amount of **P88,750.00** and GAD Attribution in the amount of **P109,879.45**, approved by the Sangguniang Barangay on December 30, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the said CY 2021 Barangay Annual Budgets, show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;
