RESOLUTION REQUESTING FOR THE AMENDMENT/CORRECTION IN THE TOTAL AREA OF THE BEACH FOREST TO EXCLUDE THE 1.7 HECTARES TITLED PROPERTIES AT POBLACION 9 IN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOILO PROVINCIAL GOVERNMENT

WHEREAS, on June 2, 2014, the Sangguniang Bayan of Tigbauan passed Resolution No. 2014-073, authorizing the Municipal Mayor, Atty. Suzette T. Aquisada to Enter Into a Memorandum of Understanding (MOU) with the Iloilo Provincial Government for the implementation of the Beach Forest Project;

WHEREAS, said Beach Forest Project was conceptualized to give way for the Action for Re-greening and Transformation (ART), a Climate Change Adaptation Program of the Iloilo Provincial Government, then under the leadership of Former Governor Arthur Defensor, Sr.;

WHEREAS, the Iloilo Provincial Government Environment and Natural Resources Office has identified a total area of 10 hectares stretching from the foot of Sibalom Bridge at Barangay 9, Poblacion, stretching along coastal barangays up to Barangay Barroc, of this municipality;

WHEREAS, on a Field Assessment Report, dated December 18, 2020, Subject: Rapid Coastal Geo-hazard Assessment with Beach Forest Monitoring in the Municipality of Tigbauan, it was found out that portions of titled properties overlapped with the Beach Forest Project;

WHEREAS, a total of 1.7 hectares: 1.3 hectares owned by Ma. Pilar Pestaño, T-217129, and 4,000 square meters, owned by Good Fortune International, Inc., TCT 090-2020000201, are private properties and should not be included in the Beach Forest;


NOW THEREFORE, on motion of HON. JULIUS T. LEDESMA, Vice Chairman, Committee On Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation (*under the sponsorship of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, Committee Chairperson*) and duly seconded by Hon. Neri T. Camiña, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie Teruñez, Be It,

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution requesting for the amendment/correction in the total area of the beach forest to exclude the 1.7 hectares titled properties at Poblacion 9 in the Memorandum of Agreement (MOA) with the Iloilo Provincial Government;

RESOLVED FURTHER, to submit copies of this resolution to the Iloilo Provincial Government, thru the Office of the Governor and the PGENRO for their appropriate actions.
