RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM SECRETARY WENDEL E. AVISADO OF THE DEPARTMENT OF BUDGET AND MANAGEMENT THRU GOVERNOR ARTHUR R. DEFENSOR, JR., IN THE AMOUNT OF TWO HUNDRED MILLION PESOS (P200,000,000.00), FOR THE CONSTRUCTION OF A REINFORCEMENT INFRASTRUCTURE TO SHIELD THE VULNERABLE COMMUNITY FROM STORM SURGES AND FLOODING IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Municipality of Tigbauan is a coastal town in the southern part of the Province of Iloilo, Region VI - Western Visayas;

WHEREAS, the mouth of Sibalom River pours to the sea along Barangay 9, Poblacion, this municipality, making the area vulnerable to storm surge, flooding and erosion;

WHEREAS, the foot of the Sibalom Bridge is a witness to a number of storm surges and erosion, as it has undergone a lot of rehabilitation and repairs after the previous onset of several destructive typhoons;

WHEREAS, afore-said bridge is now undergoing expansion and a river bank protection on the other side of said bridge is now nearing its completion;

WHEREAS, there is a great danger that awaits if a riverbank protection and/or a reinforcement infrastructure will not be constructed on the other side of the bridge, as it is just a few meters away from the sea;

WHEREAS, LGU-Tigbauan, Iloilo has no enough funds for the much needed infrastructure project to shield the vulnerable community from storm surge, flooding and erosion;


NOW THEREFORE, on motion of **HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO**, *Chairperson, Committee On Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation jointly* with **HON. NORBERTO T. TURALBA**, *Chairman, Committee on Infrastructure and General Services* and duly seconded by Hon. Dennis T. Valencia, Hon. Neri T. Camiña, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Jerry T. Tuares and Hon. Dyossa Marie Teruñez,

RESOLVED, to request financial assistance from Secretary Wendel E. Avisado of the Department of Budget and Management, thru Governor Arthur R. Defensor, Jr, in the amount of Two Hundred Million Pesos (P200,000,000.00), for the construction of reinforcement infrastructure to shield the vulnerable community from storm surges and flooding in the Municipality of Tigbauan, Province of Iloilo;
