**Resolution No. 2021-027**

RESOLUTION DECLARING AS **LEGAL** AND **VALID** BARANGAY BAGACAY ORDINANCES: **NO. 2020-001** – “DESIGNATING HOUSE NUMBER AMONG THE REGISTRY OF BARANGAY INHABITANTS IN BARANGAY BAGACAY, TIGBAUAN, ILOILO”, **NO. 2020-002** – “AN ORDINANCE DECLARING DECEMBER 2 OF EVERY YEAR AS BARANGAY DAY IN BARANGAY BAGACAY, TIGBAUAN, ILOILO” AND **NO. 2020-003** – “AN ORDINANCE ADOPTING THE OFFICIAL LOGO OF THE BARANGAY.”

WHEREAS, the above-mentioned Barangay Ordinances were endorsed by Mr. Aurelio Ticorda, MLGOO IV, this municipality last February 9, 2021 after corrections and amendments. Likewise last February 10, 2021 S.B.’s Regular Session, these Barangay Ordinances were referred jointly to the S.B. Committee on Rules, Ordinances, Resolutions and Legal Matters and S.B. Committee on Barangay Affairs for review and recommendations, and the following were the findings:

Said barangay ordinances were adopted and approved by the Sangguniang Barangay on December 6, 2020 and were presented in a Barangay Assembly last November 15, 2020 and are consistent with the provisions of Section 391 of the Local Government Code, to wit:

**SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:**

**(1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;**

**(24) Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;**

**x x x;”**

WHEREAS, the same are also consistent with SECTION 16 of the LGC which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of

appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;


NOW, THEREFORE, on motion of HON. JERRY T. TUARES, Chairman, Committee on Barangay Affairs (*under the co-sponsorship of the Committee on Rules, Ordinances, Resolutions and Legal Matters chaired by Vice Mayor Virgilio T. Teruel*) and duly seconded by Hon. Dennis T. Valencia, Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to declare as **Legal** and **Valid** Barangay Bagacay Ordinances: **No. 2020-001** – “Designating House Number Among the Registry of Barangay Inhabitants in Barangay Bagacay, Tigbauan, Iloilo”, **No. 2020-002** – “An Ordinance Declaring December 2 of Every Year as Barangay Day in Barangay Bagacay, Tigbauan, Iloilo” and **No. 2020-003** – “An Ordinance Adopting the Official Logo of the Barangay;”
