RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRAANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH BARANGAYS SERMON, DANA O AND BAGUMBAYAN FOR THE TRANSFER OF FUNDS IN THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00) EACH FOR THE PURCHASE OF BARANGAY RESPONDER VEHICLE.

WHEREAS, under the Local Government Code of 1991 otherwise known as RA 7160, Local Government Units are mandated to address the needs of its constituencies, and empower the people through direct participation in the affairs of government, by allowing them the widest possible apace to decide on, initiate, implement, and innovate on development activities that address their identified needs;

WHEREAS, as convergence strategy, the Municipal Government of Tigbauan recognizes and appreciates the efforts and participation of the Barangay Councils in responding to the needs of its constituents;

WHEREAS, the Municipality of Tigbauan has appropriated the amount of *Three Hundred Thousand Pesos (P300,000.00) for the Purchase of Barangay Responder Vehicle* as identified in the 2021 20% IRA Development Fund and Municipal Annual Investment Plan;

WHEREAS, said barangays requested for the release of the above-mentioned amount to implement the project;

WHEREAS, the amount of THREE HUNDRED THOUSAND PESOS (P300,000.00) each shall be transferred to Barangays Sermon, Danao and Bagumbayan, for them to implement the said project;

WHEREAS, premises considered, the Parties hereby agree to the following:

1. The Municipality of Tigbauan will monitor and evaluate the purchase of the vehicle;
2. The three (3) barangays concerned shall:

- a. Take full responsibility in the proper disposition/disbursement of funds in the implementation of said project in accordance with the implementing Guidelines and COA rules and regulations;
- b. Use the funds of the Tigbauan Municipal Government solely for the implementation of the specific project;
- c. After each assistance, the Accountable Officer shall prepare and submit to the Tigbauan Municipal Government the Statement of Expenditures duly signed by the Barangay Treasurer and verified by COA;


