**Resolution No. 2021-035**

RESOLUTION CONFORMING AND APPROVING THE **A.)** CY 2021 ANNUAL BUDGETS OF BARANGAYS BUGASONGAN, GUISIAN, ISIAN AND SIPITAN AND **B.)** CY 2020 SUPPLEMENTAL BUDGETS OF BARANGAY GUISIAN, BUGASONGAN AND ISIAN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on March 2, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization of the a.) CY 2021 Annual Budgets of Barangays Bugasongan, Guisian, Isian and Sipitan b.) CY 2020 Supplemental Budgets of Barangays Guisian, Bugasongan and Isian, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

**a.) CY 2021 Annual Budgets and 20% Development Funds of the following barangays, to wit:**

*The appropriation of Brgy. Bugasongan for the Annual Budget CY 2021 in the amount of **P1,602,000.00** and 20% Development Fund in the amount of **P318,617.80** approved by the Sangguniang Barangay on December 20, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;*

*The appropriation of Brgy. Guisian for the Annual Budget CY 2021 in the amount of **P1,667,000.00** and 20% Development Fund in the amount of **P330,292.80** approved by the Sangguniang Barangay on December 30, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;*

*The appropriation of Brgy. Isian for the Annual Budget CY 2021 in the amount of **P1,760,000.00** and 20% Development Fund in the amount of **P349,102.60** approved by the Sangguniang Barangay on December 30, 2020 and was enacted thru Appropriation Ordinance No. 2020-02;*

*The appropriation of Brgy. Sipitan for the Annual Budget CY 2021 in the amount of **P1,806,000.00** and 20% Development Fund in the amount of **P358,669.60** approved by the Sangguniang Barangay on December 30, 2020 and was enacted thru Appropriation Ordinance No. 2020-02.*

**b.) CY 2020 Supplemental Budgets of the following barangays, to wit:**

The appropriation of **Brgy. Guisian** for the Supplemental Budget No. 2020-01 embodying Appropriation Ordinance No. 2020-01 in the amount of **P17,985.00** is for the *One-Time Service Recognition Incentives CY 2020 chargeable against the MOOE-Training Expenses-17,985.00 of the aforementioned barangay.*

The appropriation of **Brgy. Bugasongan** for the Supplemental Budget No. 2020-01 embodying Appropriation Ordinance No. 2020-01 in the amount of **P50,000.00** is for the *One-Time Service Recognition Incentives CY 2020 chargeable against the PS Savings/Surplus CY 2020-50,000.00 of the aforementioned barangay.*

The appropriation of **Brgy. Isian** for the Supplemental Budget No. 2020-01 embodying Appropriation Ordinance No. 2020-01 in the amount of **P13,200.00** is for the *One-Time Service Recognition Incentives CY 2020 chargeable against the MOOE-Training Expenses-13,200.00 of the aforementioned barangay.*

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned Annual Budgets and Supplemental Budgets which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
