RESOLUTION CONFORMING AND APPROVING THE **A.)** CY 2021 SK ANNUAL BUDGETS OF BARANGAYS 8 (POBLACION), DAPDAP, GUISIAN, SAN RAFAEL AND TARO AND **B.)** CY 2021 SK SUPPLEMENTAL BUDGET OF BARANGAY NAPNAPAN SUR, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on March 17, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization of the a.) CY 2021 SK Annual Budgets of Barangays 6 (Poblacion), Dapdap, Guisian, San Rafael and Taro b.) CY 2021 SK Supplemental Budget of Barangay Napnapan Sur, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

a.) CY 2021 SK Annual Budgets of the following barangays, to wit:

*The appropriation of **Brgy. 8 (Poblacion)** for the SK Annual Budget CY 2021 in the amount of **P264,900.00** to be utilized for the General Administrative Program in the amount of P59,900.00 and SK Development Empowerment Program in the amount of P205,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Dapdap** for the SK Annual Budget CY 2021 in the amount of **P201,800.00** to be utilized for the General Administrative Program in the amount of P93,800.00 and SK Development Empowerment Program in the amount of P108,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Guisian** for the SK Annual Budget CY 2021 in the amount of **P166,700.00** to be utilized for the General Administrative Program in the amount of P72,000.00 and SK Development Empowerment Program in the amount of P94,700.00 of the aforementioned barangay.*

*The appropriation of **Brgy. San Rafael** for the SK Annual Budget CY 2021 in the amount of **P172,000.00** to be utilized for the General Administrative Program in the amount of P68,500.00 and SK Development Empowerment Program in the amount of P103,500.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Taro** for the SK Annual Budget CY 2021 in the amount of **P177,500.00** to be utilized for the General Administrative Program in the amount of P59,000.00 and SK Development Empowerment Program in the amount of P118,500.00 of the aforementioned barangay.*

b.) CY 2021 SK Supplemental Budget of the following barangay, to wit:

The appropriation of **Brgy. Napnapan Sur** for the SK Supplemental Budget No. 2021-01 embodying Appropriation Ordinance No. 2021-01 in the amount of **P713,671.89** is for the MOOE-31,171.89, Capital Outlay-346,000.00, Health-184,500.00, Education-95,000.00, Governance-5,000.00, Active Citizenship-42,000.00 and Environment-10,000.00 chargeable against the SK Fund Savings CY 2013, 2014, 2015, 2016, 2017 and 2020 of the aforementioned barangay.

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned SK Annual Budgets and Supplemental Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
