RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO AN ON-THE-JOB TRAINING AGREEMENT WITH THE RRLS ICT ACADEMY, ILOILO CITY FOR THE ON-THE-JOB TRAINING (OJT) PROGRAM FOR STUDENTS.

WHEREAS, RRLS ICT Academy in its letter dated March 25, 2021 to Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor, requested to accommodate **Mea T. Torda**, their graduating student of 2-year Computer Technology on her application for a 300-hour practicum/apprenticeship in this LGU Office;

WHEREAS, RRLS ICT Academy and LGU-Tigbauan agree to establish the following conditions on this On-The-Job-Training:

1. Neither the college nor the training establishment shall be under any obligation to hire or secure a job for the student-trainee after his/her training period;
2. Neither the college nor the training establishment shall be held liable for any untoward incident or sickness arising from the On-The-Job Training;
3. The student-trainee shall not be made to work over time, nor to take over the position of any employee of the training establishment, nor be compensated either as a substitute or a regular employee;
4. The college and the training establishment reserve the rights to terminate the On-The-Job Training of the student for reason found to be justifiable; and
5. The parents or guardian of the student-trainee shall be responsible for the personal needs and conduct of their son/daughter during the training period.
