**Resolution No. 2021-040**

RESOLUTION CONFORMING AND APPROVING THE CY 2021 SK ANNUAL BUDGETS OF BARANGAYS ATABAYAN, BAGACAY, BAGUMBAYAN, BINALIUAN MENOR, CORDOVA NORTE, CORDOVA SUR, NAGBA, OLO BARROC AND PARARA SUR, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on March 24, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization of the CY 2021 SK Annual Budgets of Barangays Atabayan, Bagacay, Bagumbayan, Binaliuan Menor, Cordova Norte, Cordova Sur, Nagba, Olo Barroc and Parara Sur, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

**a.) CY 2021 SK Annual Budgets of the following barangays, to wit:**

*The appropriation of **Brgy. Atabayan** for the SK Annual Budget CY 2021 in the amount of **P386,500.00** to be utilized for the General Administrative Program in the amount of P167,000.00 and SK Development Empowerment Program in the amount of P219,500.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Bagacay** for the SK Annual Budget CY 2021 in the amount of **P277,600.00** to be utilized for the General Administrative Program in the amount of P184,000.00 and SK Development Empowerment Program in the amount of P93,600.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Bagumbayan** for the SK Annual Budget CY 2021 in the amount of **P302,500.00** to be utilized for the General Administrative Program in the amount of P137,500.00 and SK Development Empowerment Program in the amount of P165,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Binaliuan Menor** for the SK Annual Budget CY 2021 in the amount of **P205,300.00** to be utilized for the General Administrative Program in the amount of P84,000.00 and SK Development Empowerment Program in the amount of P121,300.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Cordova Norte** for the SK Annual Budget CY 2021 in the amount of **P297,500.00** to be utilized for the General Administrative Program in the amount of P137,500.00 and SK Development Empowerment Program in the amount of P160,000.00 of the aforementioned barangay.*

The appropriation of **Brgy. Cordova Sur** for the SK Annual Budget CY 2021 in the amount of **P278,500.00** to be utilized for the General Administrative Program in the amount of P163,500.00 and SK Development Empowerment Program in the amount of P115,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Nagba** for the SK Annual Budget CY 2021 in the amount of **P206,500.00** to be utilized for the General Administrative Program in the amount of P80,000.00 and SK Development Empowerment Program in the amount of P126,500.00 of the aforementioned barangay.

The appropriation of **Brgy. Olo Barroc** for the SK Annual Budget CY 2021 in the amount of **P176,700.00** to be utilized for the General Administrative Program in the amount of P96,700.00 and SK Development Empowerment Program in the amount of P80,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Parara Sur** for the SK Annual Budget CY 2021 in the amount of **P368,700.00** to be utilized for the General Administrative Program in the amount of P238,700.00 and SK Development Empowerment Program in the amount of P130,000.00 of the aforementioned barangay.

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned SK Annual Budgets which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;


