Resolution No. 2021-045

RESOLUTION DISMISSING ADMINISTRATIVE CASE NO. 2021-001, ISIDRO MINERVA VERSUS LEONARDO NULOD AND CASE NO. 2021-002, ISIDRO MINERVA VERSUS KGD. CONRADO AQUINO, BOTH OF BARANGAY BARROC, THIS MUNICIPALITY.

WHEREAS, Isidro Minerva filed with the Office of the Sangguniang Bayan, Administrative Case No. 2021-001 against Punong Barangay Leonardo Nulod, and Administrative Case No. 2021-002 against Barangay Kagawad Conrado Aquino, for Abuse of Authority;

WHEREAS, it was alleged that Punong Barangay Leonardo Nulod and Kagawad Conrado Aquino committed ABUSE OF AUTHORITY when they caused the construction of a fence beside the Barroc Barangay Hall, blocking the 3-meter foot walk reflected on a Subdivision Plan which was approved by the Bureau of Lands;

WHEREAS, it was also alleged that Punong Barangay Leonardo Nulod was selective in serving his constituents, as when he refused to sign and return a certification of residency requested by the Minerva Family which was required for returning residents during the period of the COVID-19 pandemic;

WHEREAS, in an affidavit executed by a certain Gloria Generoso as a support to the complaint of Mr. Minerva against PB Nulod, she stated that she did complain with the DSWD for inclusion in the SAP, she being a pensioner receiving less than P4,000 together with her son who is a jeepney driver;

WHEREAS, to commence the investigation an Ad Hoc Committee was created, composed by Hon. Atty. Ma. Gerrylin Camposarado, as Chairman, with Hon. Marlon Teruñez and Hon. Suzette Marie H. Banno, as members;

WHEREAS, upon failure of the Respondents to file their Answers to the Complaint, the Members of the Ad Hoc Committee were constrained to do their Evaluation and start with the conduct of the Investigation based on the Evidences submitted by the Complainant;

WHEREAS, during the investigation and ocular inspection it was found out that the closure of the foot walk was not intentionally initiated by the Barangay Officials complained of, as it was due to the stockpiling of the debris coming from the road-widening project of the DPWH, which reason was also stated in the affidavit signed by a certain Johnar T.Tipo, annexed to the complaint;

WHEREAS, in a meeting called for between the complainant and the respondents, both parties agreed that Barangay Barroc, through Punong Barangay Leonardo Nulod shall re-open the Foot Walk as reflected in the Approved Subdivision Plan of Rafael Mariquina Et. Al, and to allow the Tipo Family to develop the same to serve as road-right-of-way for the interior lots;

WHEREAS, by way of reciprocating the reopening of the foot walk in the lot owned by the barangay, the Minerva Family shall no longer disturb the encroachments of the Chapel and the Senior Citizen's Bldg., and shall allow passage of the barangay in going to and from Zone 3;

WHEREAS, the allegations as to selective service of the constituents was negated by the denial of receipt of request for issuance of certificate of residency and that a pro-forma certification for IATF requirements is a ministerial function of the Office of the Punong Barangay;

WHEREAS, the allegations of favoritism in the listing of SAP beneficiaries was negated by the fact that approval of the list was lodged with the DSWD and that as Punong Barangay, PB Nulod has been assisting his constituents in making appeals and asking for reconsiderations with said agency concerned;

WHEREAS, said agreements were made during the meeting, and both parties agreed to put an end to the controversy;


NOW, THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, *Chairperson, Ad Hoc Committee on Adm. Case No. 2021-001 & No. 2021-002* and duly seconded by Hon. Dennis T. Valencia, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba and Hon. Jerry T. Tuares;

Be it resolved, as it is hereby **RESOLVED** to dismiss Administrative Case No. 2021-001, Isidro Minerva *Versus* Leonardo Nulod and Case No. 2021-002, Isidro Minerva *Versus* Kgd. Conrado Aquino, Both of Barangay Barroc, this Municipality.

RESOLVED FURTHER, to forward copies of this resolution to Mr. Isidro Minerva, Punong Barangay Leonardo Nulod, Barangay Kgwd. Conrado Aquino, Mr. Aurelio Ticorda, MLGOO, Office of the Mayor for their information and appropriate action.
