RESOLUTION INTERPOSING NO OBJECTION TO THE CUTTING/REMOVAL OF TREES ALONG ILOILO-ANTIQUE ROAD LOCATED AT BARANGAY BAGUINGIN, TIGBAUAN, ILOILO, TO GIVE WAY FOR THE ROAD WIDENING OF ILOILO-ANTIQUE ROAD INCLUDING RIGHT OF WAY, AND THE BRIDGE-WIDENING PROJECT - BAGUINGIN PARALLEL BRIDGE, ALONG ILOILO-ANTIQUE ROAD, OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH).
