RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH WESTERN VISAYAS – CENTER FOR HEALTH DEVELOPMENT (DOH WV CHD) FOR THE IMPLEMENTATION OF THE MEASLES, RUBELLA AND ORAL POLIO VACCINE SUPPLEMENTAL IMMUNIZATION ACTIVITY (MR OPV SIA) 2021 IN THE MUNICIPALITY OF TIGBAUAN

WHEREAS, the DOH Department Memorandum 2020-0378 entitled: “*Interim Guidelines in the Implementation of a Measles, Rubella and Polio Immunization Activity (MR Polio SIA)*”, reiterated the urgency of interrupting the transmission of measles, rubella and polio viruses in the country;

WHEREAS, the low fully immunized child (FIC) rate in 2020 renders Western Visayas susceptible to the aforementioned vaccine preventable diseases, hence MR OPV SIA was conducted from February to March 2021 as part of the Phase II – implementing regions;

WHEREAS, the Department of Health – Center for Health Development Western Visayas through its Regional Order No. 6 S. 2021- “*Regional Guidelines on the Provision of Funds in Support to the Implementation of the Measles Rubella and Oral Polio Vaccine Supplemental Immunization Activity 2021 in Western Visayas*”, aims to provide remuneration to all who participated during the MR OPV SIA;

WHEREAS, for and in consideration of the foregoing premises the DOH WV CHD hereby allocates the maximum amount of Two Hundred Thirty Thousand Nine Hundred Twenty (Php. 230,920.00) Pesos as grants to the Municipality of Tigbauan chargeable against the SAA 21-02-132 funds for the implementation of the MR-OPV SIA, subject to the following agreement as follows:

• **RESPONSIBILITIES OF THE DOH WV CHD:**

1. *The DOH WV CHD shall provide mobilization fund to the health service providers who implemented the MR OPV SIA in Region VI. This includes vaccinators, vaccination team supervisors, recorders and guides.*
2. *The DOH WV CHD shall transfer the funds amounting to Two Hundred Thirty Thousand Nine Hundred Twenty (Php. 230,920.00) Pesos to the Municipality of Tigbauan, based on 5773 children vaccinated with MR as stated under (DOH WV CHD Regional Order No. 6 s. 2021).*
3. *DOH WV CHD shall review the LGU’s accomplishment and validate through the Open Data Kit (ODK)*

4. Review and validate the HRH deployment and payroll submitted by the M/CLGUs through the PDOHO.

• **RESPONSIBILITIES OF THE MUNICIPALITY OF TIGBAUAN:**

1. Ensure that all who participated in the MR OPV SIA shall be included in the list of the vaccination team and supervisors.
2. Prepare the following documents for submission:
 - a. Accomplishment Report signed by the MHO and validated through the ODK;
 - b. List of LGU vaccination team duly signed by the head of office;
 - c. Signed payroll of the RHO/CHO staff involved in the implementation of the MR OPV SIA 2021.
3. Submit the Fund Utilization Report (FUR) together with the signed payroll shall be submitted within one month after receipt of grant, duly approved by the head of office of the LGU. Any unutilized fund can be used to support the routine immunization and other activities related to the National Immunization Program (NIP) before December 31, 2021.
