RESOLUTION CONFORMING AND APPROVING THE CY 2021 SK ANNUAL BUDGETS OF BARANGAYS ALUPIDIAN, 2 (POBLACION), CANSILAYAN, ISAUAN, LANAG AND SIPITAN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on April 28, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2021 SK Annual Budgets of Barangays Alupidian, 2 (Poblacion), Cansilayan, Isauan, Lanag and Sipitan, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

a.) CY 2021 SK Annual Budgets of the following barangays, to wit:

The appropriation of Brgy. Alupidian for the SK Annual Budget CY 2021 in the amount of P175,000.00 to be utilized for General Administrative Program in the amount of P85,000.00 and SK Development Empowerment Program in the amount of P90,000.00 of the aforementioned barangay.

The appropriation of Brgy. 2 (Poblacion) for the SK Annual Budget CY 2021 in the amount of P241,800.05 to be utilized for General Administrative Program in the amount of P103,800.05 and SK Development Empowerment Program in the amount of P138,000.00 of the aforementioned barangay.

The appropriation of Brgy. Cansilayan for the SK Annual Budget CY 2021 in the amount of P167,700.00 to be utilized for General Administrative Program in the amount of P118,700.00 and SK Development Empowerment Program in the amount of P49,000.00 of the aforementioned barangay.

The appropriation of Brgy. Isauan for the SK Annual Budget CY 2021 in the amount of P168,400.05 to be utilized for General Administrative Program in the amount of P83,400.05 and SK Development Empowerment Program in the amount of P85,000.00 of the aforementioned barangay.

The appropriation of Brgy. Lanag for the SK Annual Budget CY 2021 in the amount of P233,000.00 to be utilized for General Administrative Program in the amount of P98,500.00 and SK Development Empowerment Program in the amount of P134,500.00 of the aforementioned barangay.

The appropriation of Brgy. Sipitan for the SK Annual Budget CY 2021 in the amount of P180,600.00 to be utilized for General Administrative Program in the amount of P95,600.00 and SK Development Empowerment Program in the amount of P85,000.00 of the aforementioned barangay.

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned SK Annual Budgets which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;
