RESOLUTION ADOPTING AND APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2021-01, DATED MAY 7, 2021, *“RESOLUTION APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP), 20% INTERNAL REVENUE ALLOTMENT (IRA) FUND, GENERAL EXPENDITURES (P.S., M.O.O.E AND C.O., 5% GAD, 5% MDRRM FUND AND OTHER SOURCES) FOR CY 2022 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.”*

**WHEREAS**, the Municipal Development Council’s participation is necessary for the approval of the Annual Investment Program (AIP) 20% Internal Revenue Allotment (IRA) Fund, General Expenditures (P.S., M.O.O.E and C.O. GAD & MDRRM Fund and Other Sources) for CY 2022;

**WHEREAS**, the various programs, projects and activities were thoroughly identified, analyzed, and prioritized thru a participative workshops conducted/initiated by the MDC last February 16, 18 and 23, 2021 wherein different stakeholders from the Administrative Services Sector, Social Services Sector, Economic Services Sector, Physical Land Use/Infrastructure Development Sector and Environmental Management Sector, Social Development Sector, Economic Development Sector and Environment Management Sector participated;

**WHEREAS**, the Annual Investment Program (AIP) refers to the annual slice of the Local Development Investment Program which constitutes the total resource requirements for all programs, projects and activities like the annual capital expenditures and other operating requirements of the Local Government Unit;

**WHEREAS**, the target General Expenditures were also thoroughly discussed and explained to the body as to various budget allocations stated for each department of the local government unit and the necessary services for the general welfare of the citizenry of Municipality of Tigbauan;

**WHEREAS**, for CY 2022, the estimated amount of income totaled to **Two Hundred Fifty-Three Million Pesos (P253,000,000.00)** itemized, to wit:
