RESOLUTION ADOPTING AND APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2021-02 –*“RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR SUPPLEMENTAL APPROPRIATION IN THE TOTAL AMOUNT OF TWO MILLION SIX HUNDRED THOUSAND PESOS (P2,600,000.00) SAVINGS FROM PERSONAL SERVICES APPROPRIATION FOR THE PERIOD JANUARY 1 TO APRIL 30, 2021 FOR THE PAYMENT OF THE RETROACTIVE IMPLEMENTATION OF THE SECOND TRANCHE OF THE MODIFIED SALARY SCHEDULE FOR THE SECOND CLASS MUNICIPALITIES, AS PER DBM LBC NO. 132, DATED JANUARY 6, 2021, PURSUANT TO REPUBLIC ACT NO. 11466 FROM JANUARY 1–DECEMBER 31, 2021 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.”*

WHEREAS, R.A. No. 11466, otherwise known as the “Salary Standardization Law of 2019,” modifies the Salary Schedule for Civilian Personnel and authorizes the grant of additional benefits. The modified Salary Schedule for Civilian Personnel shall be implemented in four tranches, from FY 2020 to FY 2023;

WHEREAS, R.A. No. 11466 also provides for grant of the Mid-Year bonus as part of the Incentives under the Total Compensation Framework (TCF). Likewise, it states that the Program on Awards and Incentives for Service Excellence (PRAISE) instituted by the Civil Service Commission (CSC) pursuant to the provisions of Executive Order (EO) No. 292 (Administrative Code of 1987) shall be categorized under the incentives component of the TCF;

WHEREAS, there is a need of a Supplemental Annual Investment Program (AIP) for Supplemental Appropriation in the amount of Two Million Six Hundred Thousand Pesos (P2,600,000.00), chargeable against Savings of Personal Services Appropriation for the period January 1 to April 30, 2021 for the payment of the retroactive implementation of the Second Tranche of the Modified Salary Schedule for the Second Class Municipalities, as per DBM LBC No.132, dated January 6, 2021, pursuant to Republic Act No. 11466 from January 1 – December 31, 2021, of the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, the Municipal Development Council's participation is necessary in the approval of the Supplemental Annual Investment Program (AIP) for Supplemental Appropriation in the amount of Two Million Six Hundred Thousand Pesos (P2,600,000.00), savings from Personal Services Appropriation for the period January 1 to April 30, 2021 for the payment of the retroactive implementation of the Second Tranche of the Modified Salary Schedule for the Second Class Municipalities, as per DBM LBC No.132, dated January 6, 2021, pursuant to Republic Act No. 11466 from January 1 – December 31, 2021, of the Municipality of Tigbauan, Province of Iloilo;
