WHEREAS, the Application for Subdivision Approval No. SA-05-21-328 of **Hermogenes L. Torregue Et-Al** With OCT No. 090-2015004167, Lot No. 3317-B, With an Area of 1,209 Sq.M. More or Less, Containing Three (3) Lots Located at Barangay Parara Sur, Tigbauan, Iloilo.

WHEREAS, the purpose/intent of this application is the sale, to segregate the portions of the lot which Hermogenes Torrigue and his daughter Gleeny Torrigue purchased;

WHEREAS, the said land parcel was classified as residential in the zoning classification of the Zoning Ordinance of the Municipality of Tigbauan;

WHEREAS, the conditions of said approval shall be the following:
