RESOLUTION CONFORMING AND APPROVING THE **A.)** CY 2021 SUPPLEMENTAL BUDGETS OF BARANGAYS NAPNAPAN NORTE AND BAGUINGIN; **B.)** CY 2021 SK ANNUAL BUDGETS OF BARANGAYS BANGKAL, 9 POBLACION AND JAMOG, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on May 11, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the a.) CY 2021 Supplemental Budgets of Barangays Napnapan Norte and Baguingin b.) CY 2021 SK Annual Budgets of Barangays Bangkal, 9 Poblacion and Jamog, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

a.) CY 2021 Supplemental Budgets of the following barangays, to wit:

The appropriation of **Brgy. Napnapan Norte** for the Supplemental Budget No. 2021-01 embodying Appropriation Ordinance No. 2021-01 in the amount of **P400,000.00** is for the Labor and Materials for the improvement of Evacuation Center chargeable against 5% BDRRM Trust Fund CY 2015, 2016, 2017, 2018, 2019 and 2020 of the aforementioned barangay.

The appropriation of **Brgy. Baguingin** for the Supplemental Budget No. 2021-01 embodying Appropriation Ordinance No. 2021-01 in the amount of **P130,000.00** is for the Labor and Materials for the Repair and Maintenance of Brgy. Motor Vehicles, Additional Electricity Expenses for the Installation of Water System, Additional Office Supplies Expenses and Other Maintenance and Operating Expenses chargeable against CY 2020 MOOE Savings of the aforementioned barangay.

a.) CY 2021 SK Annual Budgets of the following barangays, to wit:

The appropriation of **Brgy. Bangkal** for the SK Annual Budget CY 2021 in the amount of **P225,500.00** to be utilized for the General Administrative Program in the amount of P89,000.00 and SK Development Empowerment Program in the amount of P136,500.00 of the aforementioned barangay.

The appropriation of **Brgy. 9 Poblacion** for the SK Annual Budget CY 2021 in the amount of **P244,800.00** to be utilized for the General Administrative Program in the amount of P100,000.00 and SK Development Empowerment Program in the amount of P144,800.00 of the aforementioned barangay.

The appropriation of Brgy. Jamog for the SK Annual Budget CY 2021 in the amount of P205,000.05 to be utilized for the General Administrative Program in the amount of P95,000.05 and SK Development Empowerment Program in the amount of P110,000.00 of the aforementioned barangay.

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned Barangay Supplemental Budgets and SK Annual Budgets which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
