RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH BUREAU OF FISHERIES AND AQUATIC RESOURCES REGIONAL OFFICE NO.6 FOR THE EFFECTIVE IMPLEMENTATION, OPERATION AND GOOD GOVERNANCE OF FISH SNACK CART PROJECT IN THE MUNICIPALITY OF TIGBAUAN

WHEREAS, the Philippine Constitution directs the State to protect the rights of the subsistence fishermen, especially local communities, to the preferential use of communal marine and fishery resources, both inland and offshore and to provide support through appropriate technology and research, adequate financial production and marketing assistance and other services;

WHEREAS, BFAR is the government agency mandated for the development, management and conservation of the country's fisheries and aquatic resources;

WHEREAS, BFAR implements the National Fisheries Program (NFP) which provides national framework and directions to develop and manage the country's fisheries resources for food security and ensures socio-economic upliftment of fisherfolk;

WHEREAS, the Department of Agriculture thru BFAR aims to deliver support for capacity enhancement to the local fisherfolk through the implementation of NFP, to maximize the economic impact of fish and fishery products in the region and to increase the awareness of the fisherfolk community of the Department of Agriculture's twin goal "*Masaganang Ani at Mataas na Kita*";

WHEREAS, the Local Government Unit has the mandate to provide its constituents extension facilities related to agriculture and fishery activities which include water and soil resource utilization, conservation projects and enforcement of fishery laws in municipal waters;

WHEREAS, for Calendar Year 2021, the Municipality of Tigbauan is the site of the fisheries project, the **FISH SNACK CART PROJECT**;

WHEREAS, the project will benefit the fisherfolk beneficiaries and the Municipality through fisheries production and generation of income;

WHEREAS, the parties concerned have willingly and jointly pledged to extend support and cooperation for the effective implementation, operation and good governance of the above-mentioned projects;

WHEREAS, for and in consideration of the foregoing premises, the Parties hereby agree and bind themselves to undertake the following:

ARTICLE I

NATURE AND OBJECTIVES OF THE PROJECT

This agreement aims for support and cooperation of the LGU and the fisherfolk community for the effective implementation, operation and good governance of fisheries projects towards improvement of the quality lives and livelihood of municipal fisherfolk.

ARTICLE II

IMPLEMENTATION STRATEGIES

1. The project will be implemented by BFAR in cooperation with the LGU;
2. BFAR 6 will provide inputs for the **FISH SNACK CART PROJECT**;
3. The Provincial Fisheries Office and the LGU will oversee the operations and implementation of the project and shall conduct a joint periodic monitoring and submit quarterly reports to the Regional Office. It shall also ensure the submission of monthly reports and other relevant data will be strictly complied;
4. The day-to-day operation and management of the project will be undertaken by the beneficiaries with technical assistance of the BFAR staff and LGU staff.

ARTICLE III

ROLES AND RESPONSIBILITIES OF THE PARTIES

The PARTIES will perform the following roles and responsibilities:

A. The **BFAR 6** shall:

1. Validate beneficiaries for the project;
2. Provide inputs for the project in accordance with the approved proposal(s) which form integral part of this agreement;
3. Conduct project orientation to the beneficiaries and LGU on the scheme of project implementation;
4. Preparation and submission of documentary requirements;
5. Ensure that the project is turned-over properly to project beneficiaries and utilized according to standard government accounting and auditing procedures;
6. Conduct project evaluation together with the Office of the Provincial Aquaculturist- Fish Division and MLGU;
7. Require the **LGU** for the monthly submission of progress report;
8. Conduct regular monitoring and evaluation of the project;
9. Ensure project sustainability through continuous management of the project through linking them with possible partner agencies;
10. In charge in the preparation of documentation material for publication.

B. The **LGU** shall:

1. Identify and submit list of beneficiaries for the project;
2. Organize and strengthen project beneficiaries activities in preparation for the creation of association or cooperative;

3. Ensure that the project inputs are turned-over properly to project beneficiaries and utilized according to standard government accounting and auditing procedures;
4. Conduct project sampling, provide technical assistance/supervision on sampling activities to project beneficiaries, conduct regular monitoring, validation and evaluation of the project;
5. Lead in the conduct of project monitoring and submit to **BFAR 6** monthly status report of the project and cooperate with the **BFAR6** monitoring team.
6. Prepare terminal report if the project is terminated or already ended its cycle;
7. Ensure project sustainability through continuous management of the project through linking them with possible partner agencies.
