RESOLUTION **REMANDING BACK** BARANGAY BINALIUAN MAYOR ORDINANCE NO. 2021-003-
“AN ORDINANCE REGULATING THE NUMBERING OF RESIDENTIAL, COMMERCIAL, PUBLIC
AND OTHER BUILDINGS IN BARANGAY BINALIUAN MAYOR, MUNICIPALITY OF TIGBAUAN,
PROVINCE OF ILOILO,” WITHOUT PREJUDICE TO ITS RE-SUBMISSION TO THIS AUGUST
BODY WHEN SUPPORTING DOCUMENT/S IN COMPLIANCE WITH SECTION 187 OF RA 7160
IS/ARE THERETO ATTACHED.

WHEREAS, the subject Barangay Ordinance was endorsed by Mr. Aurelio Ticorda, MLGOO IV, this municipality on May 27, 2021 after corrections and amendments. On the same date (May 27, 2021) during S.B.’s Regular Session, this Barangay Ordinance was referred jointly to the above Committees for review and recommendations, and the following are the findings:

Barangay Binaliuhan Mayor Ordinance was adopted and approved by the Sanggunian on March 7, 2021.

Said ordinance is likewise consistent with the provisions of Section 391 of the Local Government Code, to wit:

SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:

(1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;

(24) Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;

x x x”

WHEREAS, the same is further consistent with SECTION 16 of the LGC which provides that “every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.”

However, the above-mentioned Barangay Ordinance will be remanded back to Brgy. Binaliuan Mayor for compliance with the requirement of a Public Hearing which is mandatory pursuant to Section 187 of RA 7160;

TUARES, Chairman, Committee on Barangay Affairs (*under the co-sponsorship of the Committee on Rules, Ordinances, Resolutions and Legal Matters chaired by Vice Mayor Virgilio T. Teruel*) and duly seconded by Hon. Dennis T. Valencia, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado and Hon. Norberto T. Turalba;

RESOLVED, to remand back Barangay Binaliuan Mayor Ordinance No. 2021-003-*“An Ordinance Regulating the Numbering of Residential, Commercial, Public and Other Buildings in Barangay Binaliuan Mayor, Municipality of Tigbauan, Province of Iloilo,”* Without Prejudice to its Re-Submission to this August Body When Supporting Document/s in Compliance With Section 187 of RA 7160 is/are Thereto Attached;
