RESOLUTION CONFORMING AND APPROVING THE CY 2021 SK ANNUAL BUDGET OF
BARANGAY DORONG-AN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on July 27, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2021 SK Annual Budget of Barangay Dorong-an, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

a.) CY 2021 SK Annual Budget of the following barangay, to wit:

*The appropriation of **Brgy. Dorong-an** for the SK Annual Budget CY 2021 in the amount of **P351,000.00** to be utilized for the General Administrative Program in the amount of P173,000.00 and SK Development Empowerment Program in the amount of P178,000.00 of the aforementioned barangay.*

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned SK Annual Budget which shows apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing document/budget likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;
