RESOLUTION CONFORMING AND APPROVING THE CY 2021 SUPPLEMENTAL BUDGET OF BARANGAY 1 (POBLACION), THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on August 10, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2021 Supplemental Budget of Barangay 1 (Poblacion), this municipality to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace, to wit:

The appropriation of **Brgy. 1 (Poblacion)** for the Supplemental Budget No. 2021-01 embodying Appropriation Ordinance No. 2021-01 in the amount of **P100,000.00** is for the *Additional Funding for Improvement of Covered Gym/Evacuation chargeable against CY 2019–20% Development Fund (Continuing Construction of Drainage System) of the aforementioned barangay.*

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned Barangay Supplemental Budget which shows apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing document/budget likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;
