Resolution No. 2021-090

RESOLUTION CONFORMING AND APPROVING THE CY 2021 SUPPLEMENTAL BUDGET OF BARANGAY LINOBAYAN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on August 24, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2021 Supplemental Budget of Barangay Linobayan, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

a.) CY 2021 Barangay Linobayan Supplemental Budget, to wit:

The appropriation of **Brgy. Linobayan** for the Supplemental Budget No. 2021-01 embodying Appropriation Ordinance No. 2021-01 in the amount of **P99,975.20** is for the purchase of ICT Equipment – CCTV Monitoring Set, CPU and Laptop chargeable against the CY 2020 – Unencumbered Local Funds of said barangay.

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the Supplemental Budget of Barangay Linobayan which shows apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing document/budget likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
