RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRAANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH TIGBAUAN NATIONAL HIGH SCHOOL TO PROVIDE FUND ASSISTANCE FOR THE MAINTENANCE AND GASOLINE ALLOWANCE OF THE UTILITY VEHICLE TO BE USED FOR THE SBM-WINS INNOVATION PROJECT DUBBED AS PROJECT WOW (WINS ON WHEELS) IN PURSUANT TO THE DEPARTMENT OF EDUCATION ORDER NO. 10 SERIES OF 2016 TITLED POLICY AND GUIDELINES FOR THE COMPREHENSIVE WATER, SANITATION AND HYGIENE IN SCHOOLS (WinS) PROGRAM”.

WHEREAS, pursuant to **SBM-WinS Policy** or **DepEd Order No. 10, s. 2016 titled Policy and Guidelines for the Comprehensive Water, Sanitation and Hygiene in Schools (WinS) Program**, the DONEE acknowledges the role of its stakeholders and partners in making every project and program relative to the SBM WinS implementation possible and successful;

WHEREAS, the STAKEHOLDERS provide fund assistance for the maintenance and gasoline allowance of the utility vehicle to be used for the SBM WinS innovation project of Tigbauan National High School dubbed as PROJECT WOW (WinS on Wheels), a mobile information dissemination drive on the importance of water, sanitation and hygiene;
