RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ACQUIRE OR PURCHASE ONE (1) UNIT VEHICLE FOR THE USE OF THE OFFICE OF THE MUNICIPAL TREASURER, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, on July 07, 2021, the Sangguniang Bayan enacted Appropriation Ordinance No. 2021-002 with Supplemental Budget No. 2021-002 entitled: *“An Ordinance Appropriating for a Supplemental Budget in the Total Amount of Thirty Four Million Eight Hundred Twenty-Nine Thousand Six Hundred Pesos and Twelve Centavos (P34,829,600.12) to be Utilized for Various LGU Expenses Chargeable Against the CY 2019-2020 Savings Surplus (CY 2019-PS and MOOE Surplus in the Amount P6,722,089.20 and CY 2020-PS and MOOE Surplus in the Amount of P28,107,510.92), of the Municipality of Tigbauan, Province of Iloilo;”*

WHEREAS, one of the items included in the said Appropriation Ordinance and Supplemental Budget is the procurement of Motor Vehicle for the Treasury Services which is chargeable against Capital Outlay-Motor Vehicle in the amount of P1,300,000.00;

WHEREAS, in a letter dated October 1, 2021, the Municipal Mayor requested this August Body for the urgent passing of a resolution authorizing her in behalf of the Municipality of Tigbauan to acquire or purchase one (1) unit vehicle for the use of the Office of the Municipal Treasurer;

WHEREAS, the Resolution is one of the requirements for the procurement of the needed vehicle;

Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan to Acquire or Purchase One (1) Unit Vehicle for the Use of the Office of the Municipal Treasurer, Municipality of Tigbauan, Province of Iloilo;
