**Resolution No. 2021-101**

RESOLUTION CONFIRMING THE APPOINTMENT OF MRS. JONALYN T. TIRASOL AS MUNICIPAL ASSESSOR OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, Mrs. Jonalyn T. Tirasol holds the position of Administrative Officer IV (*Management and Audit Analyst II*), with Salary Grade 15 and is assigned in the Municipal Accounting Office;

WHEREAS, on March 27, 2018, Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada issued **Office Order No. 029, s. of 2018** addressed to Mrs. Jonalyn T. Tirasol with the subject: "Additional Duties And Responsibilities of Personnel", particularly to assist in the assessment services of the Municipal Assessor's Office as Licensed Real Estate Appraiser under the supervision of the Municipal Assessor (*aside from her actual duties in the Municipal Accounting Office as Administrative Officer IV*);
