**Resolution No. 2021-103**

RESOLUTION CONCURRING AND CONFIRMING THE FISHERY PERMIT OF MRS. EDILEN S. TENTATIVA OF BARANGAY PARARA NORTE, TIGBAUAN, ILOILO TO OPERATE THE FISHING ZONE CENTRAL (*AREA FRONTING THE COCONUT GROVE OF MRS. MARIA Z. ZAYCO*) LOCATED AT BARANGAY NAMOCON, TIGBAUAN, ILOILO WHICH WAS ISSUED BY THE MUNICIPAL MAYOR AS PER MUNICIPAL ORDINANCE NO. 2020-011- (*ENVIRONMENT CODE OF THE MUNICIPALITY OF TIGBAUAN*) CHAPTER 8, COASTAL ZONES AND RESOURCES MANAGEMENT UNDER SECTION 87)

**WHEREAS**, the public bidding on the grant of fishery privileges, concessions, lease or contracts to interested and qualified applicants for the establishment/installation of fish corrals (*punot*) or stationary fish lift net (*tangkal-tangkal*) and stationary filter nets (*saludan*) in the different fishing zones of Tigbauan, Iloilo was already conducted last August 17, 2021;

**WHEREAS**, the fishing zone Central - (*area fronting the coconut grove of Mrs, Maria Z. Zayco*) with a minimum bid amount of P15,000.00 was not bidded; there were no interested bidders for this site during said bidding schedule;

**WHEREAS**, for failure of bidding due to lack of interested parties during the scheduled date of bidding, Mrs. Edilen S. Tentativa of Barangay Parara Norte, Tigbauan, Iloilo applied for concession of Fishing Zone Central with the minimum bid amount of P15,000.00;

**WHEREAS**, the Municipal Mayor granted the fishery privilege to Edilen S. Tentativa to operate Fish Corral-Central Area at Barangay Namoccon, Tigabuan, Iloilo as per Fishery Permit No. 185 dated October 4, 2021;

**NOW, THEREFORE**, on motion of HON. NORBERTO T. TURALBA, *Chairman, Committee on Agriculture and Aquatic Resources* and duly seconded by Hon. Dennis T. Valencia, Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

**RESOLVE, AS IT IS HEREBY RESOLVED**, to concur and confirm the Fishery Permit of Mrs. Edilen S. Tentativa of Barangay Parara Norte, Tigbauan, Iloilo to operate the Fishing Zone Central (*Area Fronting The Coconut Grove Of Mrs. Maria Z. Zayco*) located at Barangay Namocan, Tigbauan, Iloilo which was issued by the Municipal Mayor as per Municipal Ordinance No. 2020-011-(*Environment Code Of The Municipality Of Tigbauan*) Chapter 8, *Coastal Zones And Resources Management Under Section 87*).
