RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRENCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY (ISAT U), ILOILO CITY FOR THE ON-THE-JOB TRAINING (OJT) PROGRAM FOR STUDENTS

WHEREAS, the Iloilo Science and Technology University, (ISAT U) Iloilo City, is a public institution of higher learning, organized and existing under Republic Act No. 10595, with office address at Burgos Street, La Paz, Iloilo City, herein represented by its University President III, Dr. Raul F. Muyong;

WHEREAS, the Municipality of Tigbauan, a Local Government Unit, is existing under the law of the Philippines with principal address at Tigbauan, Iloilo represented by its Municipal Mayor, Atty. Suzette T. Alquisada;

WHEREAS, the purpose of this Agreement is to develop academic cooperation and promote mutual understanding between the two Parties in the implementation of Community-Based Student Internship Program for AY 2021-2022 to be participated in by graduating ISAT U students;

WHEREAS, both parties agree to consider the development of mutually beneficial collaborations in the implementation of Community-Based Student Internship Program for AY 2021-2022, including but not limited to the following:

1. *Mutual cooperation in the deployment of graduating students of ISAT U who need to undergo their Community-Based Student Internship Program for AY 2021-2022 within the territorial jurisdiction of the Local Government Unit of Tigbauan.*
2. *Establish cooperation and support with one another in the implementation and monitoring of the forty percent (40%) Community-Based component of the Student Internship Program and its sixty percent (60%) Home-Based alternative activities.*

3. ISAT U shall assign Student Internship Program (SIP) Coordinators/ Supervisors while the Local Government Unit of Tigbauan will assign personnel to serve as their counterpart. Together they will determine the requirements to be complied with by the students who are deployed within the area of jurisdiction of the Local Government Unit of Tigbauan.
4. Both Parties shall establish security plans and health protocol to secure and protect the SIP Students deployed in the area under the control of the Local Government Unit of Tigbauan.

WHEREAS, prior to the implementation of the Community-Based Student Internship Program for AY 2021-2022, a Student Internship Program Guidebook will be distributed to all SIP Coordinators/ Supervisors in all campuses of ISAT U;

WHEREAS, the development and implementation of specific activities based on this Agreement will be separately negotiated and agreed upon between ISAT U and Local Government Unit of Tigbauan who shall carry out jointly the specific projects/ undertaking. Such activities shall be subject of a separate written agreement to be signed by the duly authorized representatives of the Parties. Both Parties shall agree to carry out such activities in accordance with the laws and regulations of their respective agency's governing laws;


NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, *Chairman, Committee on Education & Civil Service* and duly seconded by Hon. Dennis T. Valencia, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tigbauan to Enter Into a Memorandum of Understanding (MOU) with the Iloilo Science and Technology University (ISAT U) Iloilo City for the On-The-Job Training (OJT) Program for students;
