RESOLUTION CONFORMING AND APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2021-03, DATED OCTOBER 22, 2021, "RESOLUTION APPROVING THE IDENTIFIED PRIORITY PROJECTS RE-PROGRAMMED AND SPECIFICALLY IDENTIFIED FROM THE CONTINUING 20% DEVELOPMENT FUND, CONTINUING CAPITAL OUTLAY-EXECUTIVE SERVICES AND CY 2021 20% DEVELOPMENT FUND IN THE AMOUNT OF P32,332,902.88 AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) CONTAINING THEREOF OF THE MUNICIPALITY OF TIGBAUAN."

**WHEREAS**, the Local Chief Executive in a letter dated October 25, 2021, requested this August Body for the urgent passing of a resolution approving and conforming Municipal Development Council (MDC) Resolution No. 2021-03, dated October 22, 2021, "Resolution Approving the Identified Priority Projects Re-Programmed and Specifically Identified from the Continuing 20% Development Fund, Continuing Capital Outlay-Executive Services and CY 2021 20% Development Fund in the Amount of P32,332,902.88 and Approving the Supplemental Annual Investment Program (AIP) Containing Thereof of the Municipality of Tigbauan."

**WHEREAS**, the Municipal Development Council's participation is necessary for the approval of the identified Re-Programmed Priority Projects of the municipality as well as the approval of its Municipal Supplemental Annual Investment Program (AIP) containing such re-programmed projects;
