Resolution No. 2021- 112

RESOLUTION REQUESTING FOR THE APPROVAL OF THE ADOPTION OF “**BABAYE BANGON**” AS ONE OF THE BEST PRACTICES IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Philippine National Police issued an Unnumbered Memorandum dated April 5, 2021 entitled: Revised Guidelines and Procedures in the Determination and Recognition of PNP Best Practices;”

WHEREAS, on April 16, 2020, the Police Regional Office 6 (PRO6) through the Regional Director, Police Regional Brigadier General Rolando F. Miranda issued its Unnumbered Memorandum with the subject: *Police Regional Office 6 Implementation Plan (PRO6 IMPLAN) on PNP MC No. 2021-029, the Revised Guidelines and Procedures in the Determination and Recognition of PNP Best Practices;*”

WHEREAS, the issue on Violence Against Women (VAW) is among the serious peace and order concerns of the Iloilo Police Provincial Office. There is a pressing need to address such problem because of rampant cases which have detrimental effects not only to the peace and order situation of the community but more so in the life and well-being of women and their families;

WHEREAS, to primarily address such VAW problem, the Iloilo Police Provincial Office (IPPO) has come up with an initiative known as “**Babaye Bangon Project**”;

WHEREAS, “**Babaye Bangon**” (Women, Rise!) was implemented to address the up surge of VAW cases in the Province of Iloilo and to empower and restore the well-being of the women victims to be more active and productive members of the community; it is a declarative statement that commands a woman to take on her feet and rise after falling;

WHEREAS, the members of the Tigbauan Municipal Advisory Council for Police Transformation & Development (Tigbauan MAC-PTD) recognizes that violence against women (VAW) still occur everywhere despite the pandemic and home quarantine and needs to be addressed, hence adopting the IPPO initiative, "**Babaye Bangon Project**";

WHEREAS, from the year 2017 up to the present, the Tigbauan Municipal Police Station has recorded 20 VAW cases. The adaptation of Babaye Bangon initiative, as one of the best practices in this Municipality is vital and timely to address such issue; the phrase, "**Babaye Bangon**"- is a Hiligayon phrase which means "Woman, Rise", it was chosen to aptly describe the intention of PNP Tigbauan to protect women by addressing the VAW and empower the victims of such violence;

WHEREAS, recognizing the negative impact of VAW in the life of the victims and the community, the Tigbauan Municipal Police Station, at the advent of its adoption of the Performance Governance System through the implementation of the PNP P.A.T.R.O.L. Plan 2030, resolved to seriously address VAW by coming up with a more responsive and clearly designed initiative for the purpose;

WHEREAS, on November 2, 2021, the Tigbauan Municipal Police Station (MPS) through Police Captain Roy Diaz Castro issued Memorandum No. 2021-01, with the subject: "**Babaye Bangon Project**" Report;

WHEREAS, with the positive impact of "**Babaye Bangon Project**" not only in addressing VAW issues but also in the peace and order climate of the Municipality of Tigbauan, Province of Iloilo, it is strongly recommended that the project shall be certified as BEST PRACTICE and may be replicated in other units in order to make Tigbauan a VAW-free municipality;


NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, *Chairman, S.B. Committee on Peace & Order & Public Safety* and duly seconded by Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to request for the Approval of the Adoption of "**Babaye Bangon**" as one of the Best Practices in the Municipality of Tigbauan, Province of Iloilo;
