RESOLUTION EXPRESSING HEARTFELT SYMPATHY AND CONDOLENCES TO THE BEREAVED FAMILY OF THE LATE HONORABLE, DR. ROEL “BIBOY” TAÑEZA JARINA, FOR HIS LONG, DEDICATED AND EFFECTIVE SERVICE TO THE PEOPLE OF TIGBAUAN.

WHEREAS, Former Tigbauan Vice Mayor Hon. Dr. Roel “Biboy” Tañeza Jarina has passed away last November 2, 2021 in Tigbauan, Iloilo at the age of 52 years old;

WHEREAS, the late Vice Mayor, Hon. Dr. Roel “Biboy” T. Jarina is survived by his loving wife, Dr. Pinky Atadero Jarina;

WHEREAS, Vice Mayor Hon. Dr. Roel “Biboy” T. Jarina served his beloved Tigbauan in various capacities as **Municipal Councilor** for 3 years (*July 1, 2004 to June 30, 2007*) and **Municipal Vice Mayor** for almost 9 years (*July 1, 2007 to March 23, 2016*);

WHEREAS, during his terms of office as Member of the Municipal Council and as Municipal Vice Mayor, Hon. Dr. Roel T. Jarina had served his constituents with profound dedication, utmost sincerity and commitment. He was known to be a person of integrity, distinction and character. Among his valuable contributions were the passage of 11 ordinances and 44 resolutions which had effectively pushed to improve local legislation resulting to the betterment of our town;

WHEREAS, Hon. Dr. Roel T. Jarina is best remembered as the *Prime-Mover of the Paperless Session* of the Sangguniang Bayan of Tigbauan that had resulted to efficient and effective local legislation and public service. Such remarkable initiative was replicated by other Municipalities. Likewise, he was also known as the *Father of Stylized Folk Dance* in the Municipality of Tigbauan;

WHEREAS, aside from his unwavering commitment to public service, Hon. Dr. Roel T. Jarina was also an intelligent, efficient and dedicated practitioner in the field of Medicine that he became the **Medical Center Chief II of Western Visayas Medical Center** from March 28,

2016 to April 18, 2016 and also the **Chief of Hospital II of Western Visayas Sanitarium** from April 19, 2016 to April 19, 2017;

WHEREAS, Hon. Dr. Roel “Biboy” T. Jarina’s brand of public service will forever be etched in the hearts and minds of his kasimanwas as a source of inspiration for those who aspire to render selfless service to Tigbauan; a kind of service that is concerned with what he could offer, what he could do and what he could give rather than what he could get or receive and what he couldn’t do;

WHEREAS, aside from his outstanding service to the Municipality of Tigbauan, Vice Mayor Hon. Dr. Roel “Biboy” T. Jarina had been a good friend to everyone, kind-hearted, generous, approachable, a highly esteemed Vice Mayor and Presiding Officer of the Sangguniang Bayan worthy of emulation;


