WHEREAS, the Committee on Communication, Water and Energy chaired by Hon. Reynaldo E. Tumabotabo convened to finalize their stand regarding the request of ILECO 1 after the S.B. Regular Session on October 27, 2021, 11:00 o'clock in the morning at the S.B. new Session Hall, this municipality of which Committee Report No. 2021-059 is herewith attached as "Annex A";

WHEREAS, the Committee has decided to support ILECO 1 in its quest for competitive power rates and efforts on how to improve its services;

(ILECO 1), As Against The Private Distribution Utility (DU) In The City;*


