RESOLUTION APPROVING THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2021 **IN THE TOTAL AMOUNT OF ONE MILLION EIGHT HUNDRED FIFTY THOUSAND PESOS (P1,850,000.00)** (per MDC EXECOM RESOLUTION No. 2021- 02) TO BE UTILIZED: 1.) FOR COVID-19 RESPONSE EXPENSES AND RIPRAPPING OF BUYU-AN TO CANSILAYAN ROAD IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00) (CHARGEABLE FROM CY 2016-2017 MDRRM TRUST FUND) AND 2.) FOR OVERHAULING/MAJOR REPAIRS OF FIRE TRUCK IN THE AMOUNT OF THREE HUNDRED FIFTY THOUSAND PESOS (P350,000.00) (CHARGEABLE AGAINST THE BFP FIRE CODE FEES.)
