RESOLUTION CONFORMING AND APPROVING THE **A.)** CY 2022 ANNUAL BUDGETS OF BARANGAYS CORDOVA SUR, LUBOG, BARROC, PARARA NORTE AND PARARA SUR; **B.)** CY 2021 SUPPLEMENTAL BUDGET OF BARANGAY CORDOVA NORTE, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on November 17, 2021 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the a.) CY 2022 Annual Budgets of Barangays Cordova Sur, Lubog, Barroc, Parara Norte and Parara Sur b.) CY 2021 Supplemental Budget of Barangay Cordova Norte, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

a.) CY 2022 Annual Budgets of the following barangays, to wit:

*The appropriation of **Brgy. Cordova Sur** for the Annual Budget CY 2022 in the amount of **P3,815,000.00** and 20% Development Fund in the amount of **P688,728.80**;*

*The appropriation of **Brgy. Lubog** for the Annual Budget CY 2022 in the amount of **P2,525,000.00** and 20% Development Fund in the amount of **P495,313.40**;*

*The appropriation of **Brgy. Barroc** for the Annual Budget CY 2022 in the amount of **P4,560,000.00** and 20% Development Fund in the amount of **P890,072.80**;*

*The appropriation of **Brgy. Parara Norte** for the Annual Budget CY 2022 in the amount of **P4,560,000.00** and 20% Development Fund in the amount of **P889,029.60**;*

*The appropriation of **Brgy. Parara Sur** for the Annual Budget CY 2022 in the amount of **P4,900,000.00** and 20% Development Fund in the amount of **P954,753.40**;*

a.) CY 2021 Supplemental Budget of the following barangay, to wit:

*The appropriation of **Brgy. Cordova Norte** for the Supplemental Budget No. 2021-01 embodying Appropriation Ordinance No. 2021-01 in the amount of **P108,977.00** is for the Renovation of Multi-Purpose Hall chargeable against CY 2020- Unencumbered Local Funds of the aforementioned barangay.*

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned Barangay Annual and Supplemental Budgets which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
