

RESOLUTION INTERPOSING NO OBJECTION TO THE CUTTING/REMOVAL OF TREES RELATIVE TO THE PROPOSED CONSTRUCTION OF BUYU-AN RIVER FLOOD CONTROL PROJECT IN TIGBAUAN, ILOILO

WHEREAS, the 1st District Engineering Office is tasked with the implementation of construction of the Buyu-an River Flood Control Project under the Local Infrastructure Program of the Department of Public Works and Highways;

WHEREAS, the Office of the Mayor has forwarded to the Office of the Sangguniang Bayan a request of the DPWH 1st District Engineering Office for the passage of a resolution interposing no objection to the cutting of trees on the affected area, together with a list and number of trees that need to be cut/removed as determined by the Community Environment and Natural Resources Office (CENRO) Officer;

WHEREAS, between two environmental concerns: the cutting of trees and the construction of a flood control infra project, there is now a need to sacrifice the other to give way to one which will give a greater impact on the welfare of the people;

WHEREAS, LGU Tigbauan may interpose no objection to the cutting of trees provided that planting of replacement trees by the DPWH and its Contractors through the DENR to be within the territorial jurisdiction of the Municipality of Tigbauan;

NOW, THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, *Chairperson, S.B.
