**Resolution No. 2021-123**

RESOLUTION REQUESTING THE DENR THRU CENRO GUIMBAL THAT PLANTING OF REPLACEMENT TREES FOR TREES CUT WITHIN THE TERRITORIAL JURISDICTION OF TIGBAUAN TO GIVE WAY FOR THE IMPLEMENTATION OF THE DIFFERENT INFRASTRUCTURE PROJECTS OF THE DPWH, BE DONE IN THE TIGBAUAN BEACH FOREST AREA AND THE ANDRES GATON TABALDO ECO-TOURISM PARK IN BARANGAY SUPA, TIGBAUAN, ILOILO

WHEREAS, the Department of Public Works and Highways (DPWH) has in so many instances requested the Sangguniang Bayan of Tigbauan for resolutions interposing no objection to the cutting of trees to give way for the implementation of several infrastructure projects;

WHEREAS, the DENR thru Community Environment and Natural Resources Office (CENRO) Guimbal has furnished LGU Tigbauan with inventory/lists of trees to be cut/removed to give way for their different projects of the DPWH;

WHEREAS, LGU Tigbauan had never interposed any objection to the cutting of trees but has always been consistent with its request that planting of replacement trees by the DPWH and its Contractors and the DENR shall be made within the Municipality of Tigbauan;

Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation* and duly seconded by Hon. Dennis T. Valencia, Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba and Hon. Jerry T. Tuares;

RESOLVED, to request the DENR thru CENRO Guimbal that planting of replacement trees for trees cut within the territorial jurisdiction of Tigbauan to give way the DPWH projects, be done at the Tigbauan Beach Forest area and the Andres Gaton Tabaldo Eco-Tourism Park in Brgy. Supa, Tigbauan, Iloilo.

RESOLVED FURTHER, to forward copies of this Resolution to the Office of the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, to DPWH thru the 1<sup>ST</sup> District Engineering Office and all concerned for their information and/or appropriate action.
