## Resolution No. 2021-133

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ILOILO PROVINCIAL GOVERNMENT FOR THE AUGMENTATION OF EXPENSES FOR BAKUNAHAN II.

WHEREAS, in a letter dated December 14, 2021, the Hon. Mayor, Atty. Suzette T. Alquisada, requested this August Body for the urgent passing of a *"Resolution Authorizing the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan to Enter Into A Memorandum of Agreement With the Iloilo Provincial Government for the Augmentation of Expenses for Bakunahan II;"* 

WHEREAS, said Memorandum of Agreement shall be made and entered into by, and between the following parties:

- The ILOILO PROVINCIAL GOVERNMENT is the local government unit with principal address at Provincial Capitol Bldg., Bonifacio Drive, Iloilo City represented by HON. ARTHUR R. DEFENSOR, JR., Governor Province of Iloilo (Appropriation Ordinance No. 2020-06) as the (FIRST PARTY); and
- The MUNICIPALITY OF TIGBAUAN, a local government unit with principal address at the Municipal Hall of Tigbauan, lloilo represented by HON. SUZETTE T. ALQUISADA in her capacity as the Municipal Mayor, (by virtue of this S.B. Resolution No. 2021-133 as the (SECOND PARTY);

WHEREAS, the FIRST PARTY has appropriated the amount of Twelve Million Pesos (P12,000,000.00) to augment the expenses for Bakunahan II, a three (3) day vaccination program of the national government on December 15,16 and 17, 2021;

WHEREAS, the above-stated amount shall be proportionately distributed to all City/Municipalities in the Province of Iloilo as additional augmentation for the said program to be given as incentive and/or mobilization expenses;

WHEREAS, the turnout of vaccinees was less than the target during the conduct of Bakunahan 1 last November 29-30 and December 1, 2021, hence, there is a need to step up the rollout of the program on December 15,16 and 17, 2021 as well as during the subsequent vaccination roll-outs of the said program;

WHEREAS, the SECOND PARTY requested for the release of the above-mentioned amount to implement the COVID-19 Preventive Measures;

WHEREAS, the amount of **Three Hundred Fifty Thousand Pesos (P350,000.00)** shall be transferred to the SECOND PARTY for the purpose thereof;

WHEREAS, for and in consideration of the foregoing premises, the parties hereby agree as follows:

- 1. The FIRST PARTY shall require the SECOND PARTY the submission of fund utilization on the COVID-19 Preventive Measures upon its completion and submission of report of disbursement of the said fund within six (6) months starting from the date of activity;
- 2. The SECOND PARTY shall issue official receipt evidencing the receipt of the amount;
- 3. The SECOND PARTY shall submit Resolution of the Sanggunian authorizing the Municipal Mayor to sign the Memorandum of Agreement (MOA);
- 4. The SECOND PARTY shall disburse the above-cited fund for the purposes intended as per request and in accordance with the approved guidelines on utilization fund for COVID-19 Preventive Measures;
- 5. The SECOND PARTY shall return the excess or unused amount for the COVID-19 Preventive Measures to the FIRST PARTY, if any;
- 6. The SECOND PARTY shall submit and strictly comply with the approved Breakdown of expenses subject to applicable Commission on Audit rules and regulations.

NOW, THEREFORE, on motion of HON. SUZETTE MARIE HILADO-BANNO, Chairperson, Committee on Health and Sanitation and duly seconded by Hon. Dennis T. Valencia; Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan to Enter Into A Memorandum of Agreement With the Iloilo Provincial Government for the Augmentation of Expenses for Bakunahan II;

RESOLVED FURTHER, to forward copies of this Resolution to the Office of the Municipal Mayor, Atty. Suzette T. Alquisada, to the Iloilo Provincial Government and to all concerned for their information and/or appropriate action.
