**Resolution No. 2021- 136**

RESOLUTION URGENTLY DECLARING THE MUNICIPALITY OF TIGBAUAN AS UNDER A STATE OF CALAMITY DUE TO THE EFFECTS OF TROPICAL CYCLONE “ODETTE”.

WHEREAS, in accordance with the National Disaster Risk Reduction and Management Council (NDRRMC) Memorandum dated December 12, 2021 and based on the Weather Update of the Department of Science and Technology – Philippine Atmospheric, Geophysical and Astronomical Services Administration (DOST-PAGASA) on December 10, 2021, a potential Tropical Cyclone (TC) is expected to enter the Philippine Area of Responsibility (PAR) by December 14, 2021, Tuesday and will be named “ODETTE”;

WHEREAS, Section II, Article A of Republic Act 10121 upholds the people’s constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country’s institutional capacity for disaster risk reduction and management and building the resilience of local communities to disasters including climate change impacts;

WHEREAS, pursuant to the General Welfare clause of the Local Government Code, the Local Chief Executive is empowered to exercise such powers and perform duties and functions for the general welfare of the Municipality and its inhabitants, and to safeguard, preserve and protect the lives, well-being and health of its people as well as their properties;

WHEREAS, Tropical Cyclone “ODETTE”, had brought massive damage and destruction to constituents of Tigbauan particularly damages to houses, infrastructures and other properties, loss of cattle and livestock, and crops such as palay. Further, the loss of power and communications are also among the adverse effects of such calamity;

WHEREAS, the complete extent of losses and/or damages could not be immediately ascertained and assessed, as incoming reports arrive gradually and are limited because some barangays are still isolated due to widespread power interruption and loss of communication systems;

WHEREAS, "...In case of calamity and upon the recommendation of the Local Chief Executive, the Sanggunian concerned shall immediately convene within 24 hours from the occurrence of the calamity and pass a Resolution declaring the area as under a state of calamity. The Sanggunian concerned may also adopt measures to protect the lives and properties in the area and implement disaster mitigation measures". (Section 6 (a), Rules and Regulations Implementing Republic Act No. 8185 "An Act Amending Section 324 (d) R.A. No. 7160, otherwise known as the Local Government Code of 1991".);


NOW, THEREFORE, upon joint motions of HON. NERI T. CAMIÑA, Chairman, Committee on Peace and Order and Public Safety and HON. SUZETTE MARIE HILADO-BANNO, Chairperson, Committee on Women, Family, Social Services and Senior Citizens (including Indigents) and duly seconded by Hon. Reynaldo Tumabotabo, Hon. Julius Ledesma, Hon. Norberto Turalba and Hon. Jerry Tuares;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to Urgently Declare the Municipality of Tigbauan as Under A State of Calamity Due to the Effects of Tropical Cyclone "ODETTE";

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Hon. Atty. Suzette Tenefrancia-Alquisada, and all concerned for their information and appropriate action.
