RESOLUTION APPROVING THE PROVISION OF PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) TO MUNICIPAL OFFICIALS AND EMPLOYEES CHARGEABLE TO THE BUDGET OF PERSONAL SERVICES, EXECUTIVE SERVICES–OTHER PERSONNEL BENEFITS EXPENSES WITH THE TOTAL AMOUNT OF SIX HUNDRED EIGHTY-ONE THOUSAND AND FIVE HUNDRED PESOS (P681,500.00) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, in a letter dated December 20, 2021, the Hon. Mayor, Atty. Suzette T.
