RESOLUTION APPROVING THE REQUEST FOR THE RE-ALIGNMENT OF THE IDENTIFIED 20% DEVELOPMENT PROJECT FOR 2021 REHABILITATION OF FOOTBRIDGE AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (P500,000.00) TO THE PROCUREMENT OF EMERGENCY RESPONDER VEHICLE WORTH THREE HUNDRED THOUSAND PESOS (P300,000.00) AND COMPLETION OF MULTI-PURPOSE BUILDING WORTH TWO HUNDRED THOUSAND PESOS (P200,000.00) OF BARANGAY ISAUAN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, in a letter dated December 20, 2021, the Hon. Mayor, Atty. Suzette T. Alquisada, requested this August Body to hold a **special session** for the urgent passing of a *"Resolution Approving the Request for the Re-Alignment of the Identified 20% Development Project for 2021 Rehabilitation* of Footbridge Amounting to Five Hundred Thousand Pesos (P500,000.00) to the Procurement of Emergency Responder Vehicle Worth Three Hundred Thousand Pesos (P300,000.00) and Completion of Multi-Purpose *Building Worth Two Hundred Thousand Pesos (P200,000.00) of Barangay Isauan, Municipality of Tigbauan, Province of Iloilo;"*

WHEREAS, Barangay Council of Barangay Isauan passed Resolution No. 2021-049, "Resolution Requesting for the Realignment of the Identified 20% Development Project 2021 Rehabilitation of Footbridge Amounting to Five Hundred Thousand Pesos (P500,000.00) to the Procurement of Emergency Vehicle Worth Three Hundred Thousand Pesos (P300,000.00) and Completion of Multi-Purpose Building Worth Two Hundred Thousand Pesos (P200,000.00) of Barangay Isauan, Municipality of Tigbauan, Province of Iloilo;"

WHEREAS, the identified rehabilitation of footbridge, as indicated in 20% Development Fund of the Municipality for 2021 in the amount Five Hundred Thousand Pesos (P500,000.00) is not enough for the completion of the said project and the Barangay was able to access financial assistance from the provincial government for the said project in the amount of P1,700,000.00;

WHEREAS, the Barangay Council instead of the rehabilitation of footbridge project as identified in the Barangay Resolution No. 2021-049, opted for the procurement of emergency responder vehicle in the amount of P300,000.00 and the completion of Multi-purpose Building in the amount of P200,000.00;

NOW, THEREFORE, on joint motion of HON. DENNIS T. VALENCIA, *Chairman, Committee on Appropriations, Budget, Finance and Accounts* and HON. NORBERTO T. TURALBA, *Chairman, Committee Infrastructure & General Services* and duly seconded by Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado- Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;
